## DEAR PANEL MEMBERS,

A few updates this month. We're still working on the testing of the confidential site, so that will take more time to roll out.

### Electronic Appellate Records

Superior courts across the state are moving toward electronic records in favor of paper transcripts. If counsel receives an electronic record from the court and the client has no access to review the electronic copy, counsel can print the record for the client and claim the expense on the compensation claim. All charges incurred for printing the client's copy should be claimed on line 10, miscellaneous expenses. This includes cost of printing within your office, or the fee charged by a 3<sup>rd</sup> party service to print a large record. Please provide an invoice from the third-party vendor.

Please feel free to consult with your staff buddy if you have any questions about the amount or where to claim the expense.

### Requests for Exhibits

Please contact your staff buddy to request exhibits, rather than requesting them through Omar Palacio directly. There are many differences between the various superior courts and things are evolving on that front. The staff attorney can help counsel determine the best way to obtain the exhibits.

### ADI Confidential Site
