Setting up Direct Deposit with the JCC

If you are not set up for direct deposit and receive your claims checks in the mail, we strongly recommend that you apply for direct deposit. Receiving electronic payments will eliminate problems associated with receiving paper checks (e.g., lost in the mail, damaged, stolen). It takes a long time to have the check re-issued by the State Controller's Office through the JCC.
