Riverside SB 483 Appeals Initiated by the CDCR List

In most Riverside PC 1172.75 appeals that were initiated by a CDCR list, the list was not made part of the court file and is not included in the Clerk's transcript. In those cases, Division Two has asked us to advise counsel of the following:

The CDCR list that initiated proceedings must be made part of the record. If the CDCR list is not in the court file, this can be done via a motion for judicial notice, requesting notice of the CDCR list and declarations establishing that the CDCR list initiated the proceedings in appellant's case.

ADI has a sample motion for judicial notice that can be easily adapted for this purpose. Please contact your assigned staff attorney if you have a Riverside PC 1172.75 case and you suspect the list is not in the court file.
