This alerts brings some good news in terms of guideline increases and changes to the JCC policy regarding the printing of electronic transcripts.

In our earlier alert, I neglected to include the effective date of these changes. *The changes apply to all appointments on or after March 1, 2025.*

That's the only addition to this alert.

New Electronic Transcript Policy

Printing of the Electronic File and/or Transcripts Received from the Court (Expenses, Line 10, Other Expenses)

The printing of the electronic file and/or transcripts received from the court for the client is compensable at actual cost, if reasonable, when the record is requested by the client and the client is unable to receive an electronic file.

Please continue to claim the expense on "Other Expenses", Line 10 in ADI's claims program.

Claims Compensation Guideline Increases

Communication Guideline Increased to 5.0 hours (Hours, Line 1)

The JCC has increased the guideline from 3.5 hours to **5.0 hours**. Panel attorneys need only provide an explanatory comment if their claimed time exceeds 5.0 hours.

Photocopy Guideline Increase (Expenses, Line 1)

The actual cost of photocopies will be reimbursed, up to \$0.25 cents per page.

Travel Reimbursement Increases

Car Travel Breakout (Expenses, Line 6)

Actual cost of mileage will be reimbursed, up to \$0.70 per mile.

Total Travel Expenses (Expenses, Line 5)

Meals:

- Breakfast: \$12.00 (if necessary to be on the road before 7.00 a.m.);
- Lunch: \$14.25 (if related to a necessary overnight stay); and
- Dinner: \$21.00 (if necessary to be on the road after 7:00 p.m.)
